PS-416 of the president of the Republic of Uzbekistan on measures to further improve the system of Personnel Training in the field of Architecture and construction on November 8, 2022 and the Board of Governors of the Mirzo Ulugbek State University of architecture and construction of Samarkand on December 24, 2021 on additional measures to ensure academic and organizational and managerial independence of state educational institutions.

The Board of Directors of the University is the highest decision-making body on administrative issues related to the University. The board is not a legal entity. The council performs its activities on a public basis.

The board of Governors carries out its activities in accordance with the Constitution and laws of the Republic of Uzbekistan, decisions of the chambers of the Supreme Assembly of Uzbekistan, decrees, decisions and orders of the president of the Republic of Uzbekistan, decrees and orders of the Cabinet of Ministers of Uzbekistan, orders of the Ministry of Higher Education, Science and innovation and other legislation.

Board of Governors (B. in the following Council) is made up of the rector, the deans of the faculty, the director of the Higher School of Science, the faculties and the members selected from the Higher School of science. B. from the faculty. The number of members elected to the council is determined by the order of the rector. The aspect of prorectors, general secretary and representative observers from university students participate without the right to vote.

## Management of the council main duties and powers

- ❖ Development of the University's strategic plan;
- ❖ Decision on the program of activity of the University;
- ❖ Preparation and publication of a self-assessment report, which regularly evaluates the activities of the University's educational and methodological, research and public service every year, on the principles of established laws and regulations;
- ❖ Preparation of the University's investment program and budget;
- ❖ Making decisions on transfers between the structural sectors of the budget;
- ❖ To make a decision on behalf of the university to express, Buy real estate, determine the right to this real estate in favor of a third party on Real Estate belonging to the University;
- ❖ Decision on appointment of professors;
- ❖ Making decisions on issues related to the University put on the agenda by the rector;
- ❖ To deal with objections to decisions made by the boards of faculties and professional educational institutions.
- ❖ To perform other tasks specified in the law documents
